DATA PROTECTION

Data Protection Act 1984: The Competition Organiser is required to inform that the following will be stored on computer or card index for the purposes of preparing entry forms and other internal purposes:

Name, address, telephone number and other shooting connected information. This information will be for the use of Club Officials only.

If you do not wish your details to be kept in either form or you wish to view your records, please contact the Competition Organiser.

FIREARMS ACT 1968 - SECTION 21

It is an offence for someone who is prohibited by Section 21 to have a firearm or ammunition in his / her possession at any time. Section 21 applies to anybody who has been sentenced to imprisonment or to youth custody or detention in a young offenders' institution for three months or more. The period for which a person is prohibited depends on the length of their sentence; if the sentence was longer than three years, the prohibition is for life. If the sentence was of three months or more, but less than three years, the prohibition lasts for five years from the date of the person's release.

It is an offence for a person to transfer, let on hire, give or lend a firearm or ammunition to someone he/she knows or has reasonable grounds for believing to be prohibited by Section 21.

(One shot per target + 4 sighter targets (unlimited sighters))

20 YARDS PRECISION

60 SHOTS + SIGHTERS in 1 Hour 45 Mins (PL15)

(10 shots per target + 2 sighter targets (unlimited sighters))
